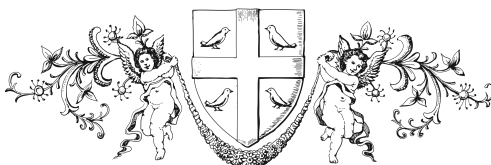

## *TOPPING UP & RECORKING/ REGULATIONS FOR THE YEAR 2023*

The Fattoria dei Barbi of Stefano Cinelli Colombini is available to carry out for its clients the topping up & recorking of the bottles of Brunello di Montalcino and Brunello di Montalcino Reserve of the Fattoria dei Barbi in their possession. This topping up & recorking is carried out according to the methods described in this regulation, and is subject to the unconditional acceptance and signature of the rules established therein.

Recorking is a necessary operation to allow Brunello to age. The caps are made of cork wood, which is an organic material and over time loses elasticity and may not adhere more perfectly to the glass. This can cause slight losses, so if you notice that this has happened, you need to bring the wine back to the right level and change the cork. Most of the corks remain perfect for many decades but, prudentially, it is advisable to change them every twenty years.

- 1) For the year 2023 topping up & recorking of bottles is **free for our customers**.
- 2) Brunello bottles must be sent or delivered directly to our cellar.
- 3) On each bottle and carton containing the bottles delivered for topping up & recorking, **a label specifying the name, surname, address, telephone and / or fax number and e-mail address** must be applied by the owner.
- 4) Topping up & recorking is only available to **bottles that have not been topped up & recorked for at least 20 years**.
- 5) We will not accept bottles in which the vintage year is illegible and / or the wine level is more than 1 centimeter lower than the bottle neck and / or bottles with extremely compromised cork and / or visually deteriorated wine.
- 6) Topping up & recorking will take place with a wine from the same vintage owned by the Fattoria dei Barbi.
- 7) Each customer can request the topping up & recorking of **no more than 12 bottles a year**.
- 8) Fattoria dei Barbi will check the bottles delivered by customers and reserves the right to decide at its sole discretion whether they are suitable or not for topping up & recorking. The preliminary operation involves a visual, olfactory and gustatory examination, that is, an examination of the state of conservation of the bottle, level and color of the characteristics of the deposit on the bottom of the bottle; olfactory examination and control tasting.

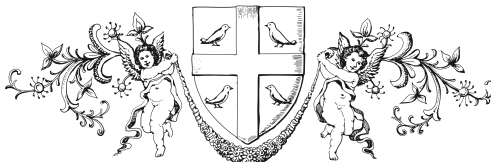

- **For the bottles considered suitable**, we will proceed with topping up the bottle with our Fattoria dei Barbi wine of the same vintage, and subsequently to the recorking with marked Barbi corks and capping.
  - **Bottles containing wine no longer suitable for consumption** will be returned to the customer or in the state in which La Fattoria dei Barbi received them or recorked with a generic cork and without capsule together with a report attesting its status.
- 9) Since 1980, the pink band of the DOCG has been affixed above the cap of the Brunello bottles. To carry out the topping up & recorking, this label must be removed and can no longer be returned. The client declares to be aware of the fact that **without the DOCG band the bottle can no longer be sold.**
- 10) **The Fattoria dei Barbi** will give all the necessary attention to carry out the operations related to the topping up & recorking but **does not assume responsibility for any breakage of the bottles left by the customer.**
- 11) The return of the bottles to the owners will be carried out as soon as the operations of topping up & recorking are completed. **The owners will be notified in good time.**
- 12) Any dispute concerning this contract or related to it, including disputes concerning the interpretation, execution, breach, termination or invalidity of the contract itself, will be resolved by an arbitration board whose ruling must be accepted as final according to the Rules of the Arbitration Chamber established at the Chamber of Commerce ("CCIAA") of Siena, Italy. The parties declare expressly to accept this Regulation, including the procedures for appointing arbitrators. The board of arbitration will be composed of three arbitrators, two of which will be appointed by each of the parties, and the third will be nominated by the other two. In the event that one of the parties, following a written request, does not name its own arbitrator within 30 (thirty) days of receipt of said request, or in case the two arbitrators do not appoint the third arbitrator within 10 (ten) days, the arbitrator or the arbitrators will be nominated by the President of the Arbitration Chamber at the Chamber of Commerce ("CCIAA") of Siena, Italy. The Arbitration venue will be Siena, Italy. The arbitrators will decide according to the law, following standard procedures. Expressly recognized is the applicability of the 1958 New York Convention on Recognition and Execution of foreign arbitration rulings.

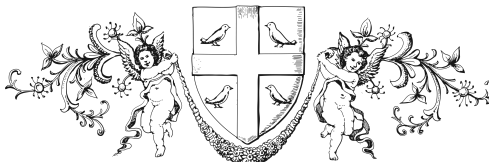

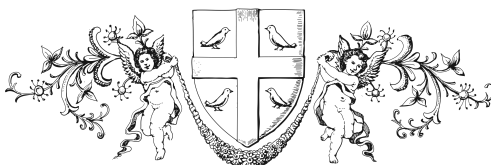
